OF INCREASED TUITION FEE

Dear Parents,

As you are aware that the Managing Committee of our school, in its meeting dated 8.12.2017 attended by DOE and Parents' representatives, has taken a unanimous decision to increase the school fee as permitted by the Directorate of Education vide order no. DE.15 (318) PSB/2016/19786 dated 17.10.2017 for implementation of the seventh Central Pay Commission in Recognized Private Unaided Schools.

However the said order came to be stayed in the proceedings held in WP (C) No. 11265/2017 titled "Ms. Taru Chauhan & Ors Vs. GNCTD & Ors". Thereafter, by way of an Order dated 1.2.2018, the aforesaid petition stands dismissed as withdrawn.

In view of the withdrawal of the said petition, the stay on mode of implementation of the Seventh CPC is no longer in operation. Accordingly, the previous Circular dated 15.12.2017 issued by the school on its website and subsequent message to the parents is still valid for payment of arrears and increase in tuition fee on account of implementation of Seventh CPC.

Accordingly, in pursuance of the decision taken in the Managing Committee Meeting dated 8.12.2017, you are hereby requested to pay the arrears of increased Tuition Fee from April,2017 to March,2018.
